## **BY-LAW NO. 6**

A By-Law respecting the Manuals of Operation (procedures, rules and other regulations) of the titled sport of the WESTERN ONTARIO ATHLETIC ASSOCIATION, a corporation without share capital subject to the *Not-for-Profit Corporations Act*, 2010 (Ontario), as listed in paragraph 5 herein.

BE IT ENACTED AND IT IS HEREBY ENACTED AS A BY-LAW OF THE WESTERN ONTARIO ATHLETIC ASSOCIATION (herein called the Corporation) as follows:

- 1. The Chairperson of each committee shall be appointed by the President or the Board and ratified by the Board, to manage each sport to:
  - (a) Set regulations and rules for participation in the sport.
  - (b) Govern the day to day management of the sport.
  - (c) Call to order an annual or other meeting of the sport.

Each Chairperson, in consultation with their committee shall select a Vice-Chairperson.

- 2. Each participating team shall be a Member of the Corporation and shall be entitled to vote in accordance with By-Law No. 1, Section 8.13 and 8.19, in regard to issues coming before the respective Annual Sport Meeting.
- 3. Each Chairperson or committee, if required, shall be the authority for the sport for which they are appointed, and each sport shall carry on in an autonomous manner so long as it complies with the By-Laws, Articles, Policies, rules, regulations, procedures and the spirit of the Corporation.
- 4. Each Chairperson or the appointee shall report to the Board with regard to all rules and decisions taken or made from time to time.
- 5. Each sport, for administrative purposes, shall be recognized by title as follows:
  - (a) PART 1 SOFTBALL
  - (b) PART 2 SENIOR HOCKEY
  - (c) PART 3 WOMEN'S HOCKEY
  - (d) PART 4 MINOR HOCKEY

DATED this 19th day of September, 2024 as By-Law No. 6 by the Directors of the Corporation at a meeting duly called and regularly held, at which a quorum was present.
